Turn right on Old Harrison pike (just past the fitness factory). Continue straight onto Tennessee Nursery Rd. The park will be just ahead on the left.

Course: This is a two loop course. There are sections of grass fields, wooded trails, sharp turns, and the asphalt loops around the park.

Awards: Male and Female divisions with ten year age groups along with over all male and female. All preregistered runners will receive a t-shirt. Those that register the day of the race will receive t-shirts while supplies last.
