4. We will supply bib numbers with bar codes for all of your runners. Please use the correct number for each runner. Competitors must pin their numbers on the front of their shirts. Pins will be provided. Do not pin the bottom tear-off portion with the bar code number.
5. A team must finish five (5) runners to score as a team.

To whom it may concern,

Please accept the following as an outline of the Morris County Park Commissions insurance requirements for the 2009 season. The certificate of insurance must be delivered to the Park Commission with the Insurance Endorsement Form (CG 20 10) provided by the insurance company.

Insurance requirements:

The minimum acceptable limits of liability, including wrongful death, shall be **\$1,000,000.00 per occurrence Bodily Injury/Property Damage liability** and **\$2,000,000.00 aggregate**.

The **Morris County Park Commission** and **The County of Morris** are to be named as additionally insured.

**MORRIS COUNTY PARK COMMISSION
AGREEMENT**

In consideration of the granting of permission by the Morris County Park Commission to the applicant for the use of facilities set forth above applicant hereby covenants and agrees to defend, indemnify and hold harmless the Morris County Park Commission, the County of Morris and all of its employees, agents, and instrumentalities thereof (collectively the "County") against any and all claims, lawsuits, proceedings and the like arising from the conduct of the actives for which this application is made, and for the use of the facilities, and any other facilities which are employed by the applicant, or their guests, whether or not any such claim or liability arises out of the activity for which this application is made, or the condition of any floor, wall, utility or furnishing within the facilities requested and used, or any passageway, space or stairway, whether or not such claim arises from any alleged act or negligence of the County or its agents, servants or employees, or of the applicant or its agents, contractors, servants or employees, or any persons or person in or about the premise or the property of any person, persons or organization or corporation occurring during the period for which the facilities requested are used, or upon the premises of the Morris County Park Commission or any road, walkway or exterior surface; said indemnity to include all of the County's counsel fees, expenses, costs, fees, liabilities, judgments and the like incurred in connection with any such claim, lawsuit or proceeding, but also any cause of action or preceding brought with respect thereto. Anything herein that may be construed to the contrary notwithstanding, this provision shall not apply to activities unrelated to the applicant.
